**St Mary & St Pancras governance arrangements are as follows:** The Full Governing Body meets each month for nine months of the year. Working Groups that report to the FGB may be convened to look at specific areas, for example budget. Panels of governors will be convened when required by the numerous policies the school has in place. A designated Admissions Committee meets on behalf of the FGB with delegated authority to decide on admissions in the spring.
